

Terms & Conditions of the STEEL Tokens sale agreement

PREAMBLE

The following terms and conditions of the STEEL Tokens sale agreement (“Agreement”) govern your (“You” or the “Purchaser”) purchase of cryptographic tokens (“STEEL Tokens”) from World Scene Limited, a company incorporated in Hong Kong, registry number 2683827 (“We”, “Us”, “SISHUB” or the “Company”). The Purchaser and the Company each are “Party” and, together, the “Parties” to this Agreement agree as follows:

ACCEPTANCE & CHANGES TO THIS AGREEMENT

1. Subject to these Terms and Conditions and Privacy Policy, the Company agrees to sell to you and you agree to purchase from Company a specific number of STEEL Tokens at the price under section 41 of this Agreement.
2. By the fact of purchase of STEEL Tokens from the Company and confirmation of acceptance of this Agreement and/or by clicking on the checkbox “I agree” at the website <http://SISHUB.network/> as such actions are a symbol of Purchaser’s signature, the Purchaser confirm that he/she/it have read this Agreement carefully and in its entirety and understand that HE/SHE/IT IS CONSENTING TO BE BOUND BY AND IS BECOMING A PARTY TO THIS AGREEMENT and any terms or agreement incorporated by reference AND AGREE THAT THIS AGREEMENT IS ENFORCEABLE LIKE ANY WRITTEN NEGOTIATED AGREEMENT SIGNED BY YOU. The Purchaser may withdraw from his/her/its obligations under this Agreement at any time under conditions of this Agreement.
3. Unless otherwise stated herein, this Agreement governs only Purchaser’s acquisition of Tokens from SISHUB during the Sale Period. Any use of STEEL Tokens in connection with providing or receiving Services in the Platform shall be governed primarily by other applicable agreements and policies. The Company may use third party services to process the Token Sale and any rules applicable by third party described in this Agreement to such processing of STEEL Tokens should also be applicable in addition to this Agreement.
4. This Agreement is intended to fully reflect the terms and conditions of the original agreement between the parties. No provision of this Agreement shall be considered waived unless such waiver is accepted by the party that benefits from the enforcement of such provision by action of a click in a specific check box with the text “I agree” at the Website, which shall be published on the Website in such case. No waiver of any provision in this Agreement,

however, will be deemed a waiver of a subsequent breach of such provision or a waiver of a similar provision. In addition, a waiver of any breach or a failure to enforce any term or condition of this Agreement will not in any way affect, limit, or waive a party's rights hereunder at any time to enforce strict compliance thereafter with every term and condition hereof.

5. The Purchaser acknowledges and accepts that this Agreement may be modified, changed, supplemented, updated at any time without prior written notice, at sole discretion of SISHUB. Your continued use of the STEEL Tokens after any amendments or alterations of this Agreement shall constitute Your consent hereto and acceptance hereof. At any case, the date of the most recent amendments and alterations will be indicated at the top of this Agreement. If the Purchaser does not agree to such revised terms of the Agreement he/she/it must stop using this STEEL Tokens and may withdraw from his/her/its obligations under this Agreement at any time under conditions of this Agreement.

INTERPRETATION

6. In this Agreement unless the opposite is clear from the context the following rules of interpretation apply:
 - 1) Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular;
 - 2) Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
 - 3) References to clauses and schedules are to the clauses and schedules of this Agreement and references to paragraphs are to paragraphs of the relevant schedule;
 - 4) A reference to any party shall include that party's personal representatives, successors and permitted assigns.
 - 5) All references to a person include firms, companies, government entities, trusts and partnerships or other or unincorporated body (whether or not having separate legal personality);
 - 6) The term 'including' does not exclude anything not listed;

- 7) A reference to a statute or statutory provision is a reference to it as amended, extended or re-enacted from time to time;
- 8) A reference to a statute or statutory provision shall include all subordinate legislation made from time to time under that statute or statutory provision.
- 9) A reference to writing or written includes fax and e-mail.
- 10) Any obligation on a party not to do something includes an obligation not to allow that thing to be done.
- 11) Any words following this Agreement including, include, in particular, for example or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding or following that agreement.
- 12) Headings of sections are for convenience only and shall not be used to limit or construe such sections. All the sections in this Agreement shall survive any termination or expiration of this Agreement.

7. The following definitions and rules of interpretation apply in this Agreement:

1. Certain statements in this Agreement and informational documents of the Company constitute "forward-looking information" under applicable laws. Except for statements of historical fact, information contained herein may constitute forward-looking statements. When used in this Agreement, the words "may," "will," "should," "project," "anticipate," "believe," "estimate", "intend," "expect," "continue," and similar expressions or the negatives thereof are generally intended to identify forward-looking statements. Forward looking statements are not guarantees of future performance, and undue reliance should not be placed on them. Such forward-looking statements necessarily involve known and unknown risks and uncertainties, which may cause actual performance on Company's obligations, market projections and financial results in future periods to differ materially from any projections of future performance or result expressed or implied by such forward looking statements. Although forward-looking statements contained herein are based upon what management believes may be reasonable assumptions, forward-looking statements may prove to be inaccurate, as actual results and future events could differ materially from those anticipated in such statements. The Company expressly disclaims any obligation or undertaking to disseminate any updates or revisions to any forward-looking statement contained herein to reflect any change in its expectation with regard thereto or any change in events, conditions, or circumstances on which any such statement is based.
2. This Agreement is intended to fully reflect the terms and conditions of the original agreement between the parties. No provision of this Agreement shall be considered waived unless such waiver is accepted by the party that benefits from the enforcement of

In addition, a waiver of any breach or a failure to enforce any term or condition of this Agreement will not in any way affect, limit, or waive a Party’s rights hereunder at any time to enforce strict compliance thereafter with every term and condition hereof.

Eligible purchasers

8. By purchasing STEEL Tokens each Purchaser covenants, represents, and warrants that (under the Applicable Law and law of the country of Purchaser’s residence):
- 1) he/she/it is of an age of majority to enter into this Agreement (at least 18 years of age), meets all other eligibility criteria and residency requirements, and is fully able and legally competent to use the Website, enter into agreement with the SISHUB and in doing so will not violate any other agreement to which he/she/it is a party;
 - 2) he/she/it has necessary and relevant experience and knowledge to deal with cryptographic Tokens, cryptocurrencies and Blockchain-based systems, as well as full understanding of their framework, and is aware of all the merits, risks and any restrictions associated with cryptographic Tokens (their purchase and use), cryptocurrencies and Blockchain-based systems, as well as knows how to manage them, and is solely responsible for any evaluations based on such knowledge;
 - 3) if he/she/it is a corporation or other legal entity, he/she/it has the right, power and authority to enter into this Agreement on behalf of the corporation or other legal entity and bind them to this Agreement;
 - 4) Is not a foreign or domestic PEP.
 - 5) he/she/it will not be using the Website for any illegal activity, including but not limited to money laundering and the financing of terrorism;
 - 6) Purchaser created an Account on the Website and accepted SISHUB Terms and Conditions, SISHUB Privacy Policy.

9. Purchaser is only allowed to purchase STEEL Tokens if and by buying STEEL Tokens he/she/it covenant, represent, and warrant that you are neither a citizen, resident or tax resident of Hong Kong and/or the United States of America (hereinafter referred to as the “U.S.” or U.S. Person under definition of Rule 902 of the U.S. Securities Act of 1933) and do not possess status of accredited investor subject to provisions of Securities Act of 1933, and countries or territories or individuals under the sanctions of the United Nations or the European Union (the list is available at:

https://eeas.europa.eu/sites/eeas/files/restrictive_measures-2017-08-04.pdf).

10. The Hong Kong and U.S. citizens and residents are not eligible and not allowed to participate in the STEEL Tokens Sale due to various taxation and regulatory issues. Purchaser is only allowed to purchase STEEL Tokens if he/she/it is neither a Hong Kong and/or U.S. citizen or permanent resident, nor Purchaser has a primary residence or domicile in Hong Kong and/or the U.S. (including Puerto Rico, the U.S. Virgin Islands, and any other possessions of the U.S.). In order to buy STEEL Tokens and by buying them Purchaser covenants, represents, and warrants that none of the owners of the company, of which Purchaser can be an authorized officer, are Hong Kong and/or U.S. citizens or permanent residents. Should this change at any time, Purchaser shall immediately notify the Company. Purchaser also represent and warrant that he/she/it is not a citizen or resident of a geographic area in which access to or use of the cryptocurrency or cryptographic tokens is prohibited by applicable law, decree, regulation, treaty, or administrative act. The Company shall reserve the right to refuse to sell STEEL Tokens to anyone who does not meet the citizenship and residence criteria set forth above. Purchasers cannot resell STEEL Tokens to citizens and residents of countries and territories restricted in this Agreement.

DESCRIPTION OF STEEL TOKENS

11. STEEL Tokens are digital cryptographic tokens based on the Ethereum protocol technology and conform to the ERC20 standard and serve as a software digital product (not being cryptocurrency), created and issued by the Company as a cryptographically secured representation of the right to exchange STEEL Token for interaction and services on the Platform and which give the Purchaser access to certain features on the Platform.

12. There will be in total 35,000,000,000 STEEL (Thirty-five thousands of millions) STEEL Tokens available (“Total STEEL Tokens Number”). 20% of STEEL tokens shall be distributed to the team members, advisors and partners. STEEL Tokens transferred to the

team will be frozen for 12 months. All unsold during the Token Sale STEEL Tokens shall be burnt.

13. STEEL Tokens carries no rights, express or implied, other than those, set out herein, subject to SISHUB development of the project. In particular, STEEL Tokens holders shall not have any influence in the development or governance of SISHUB, and STEEL Tokens do not represent or constitute any ownership right or stake, share or security or equivalent rights or any right to receive future revenue shares, or any other form of participation in or relating to SISHUB.

14. Purchaser acknowledge and accept that STEEL Tokens do not represent or constitute:

- a) any ownership right or stake, share, equity, security, commodity, bond, debt instrument or any other financial instrument or investment carrying equivalent rights;
- b) any right to receive future revenues, shares or any other form of participation or governance right from, in or relating to Company and Platform;
- c) any form of money or legal tender in any jurisdiction, nor do they constitute any representation of money (including electronic money).

15. Any potential future use of STEEL Tokens in connection with the provision or receipt of services on SISHUB Platform, shall be subject to and governed by such other applicable terms, conditions and policies relating to the use of each such service or Platform.

16. These terms and conditions regulating the use of the Platform shall be made available to the Platform users.

17. STEEL Tokens are not consumer products and its holders accepts explicitly and agree to it that they are not covered by the consumer protection regulation of any jurisdiction.

ACKNOWLEDGEMENT AND ASSUMPTION OF RISKS RELATED TO STEEL TOKENS

18. Purchaser understand that STEEL Tokens, blockchain technology, Ethereum, Ether and other associated and related technologies are new and untested and outside of SISHUB's

exclusive control and adverse changes in market forces or the technology, broadly construed, may prevent or compromise SISHUB's performance under this Agreement.

19. Purchaser agrees that no other party (including, without limitation any) may be held liable for any loss arising out of, or in any way connected with Purchaser's participation in the STEEL Tokens-sale, or receiving and holding Tokens or such risk.
20. Purchaser also acknowledges that prior to receiving STEEL Tokens he has been warned of the following risks, associated with the Website, the SISHUB Tokens, the Platform and other relevant technologies mentioned herein:

LEGAL RISKS REGARDING SECURITIES REGULATIONS

21. There is a risk that in some jurisdictions the STEEL Tokens might be considered to be a security, or that it might be considered to be a security in the future. SISHUB does not give warranties or guarantees that STEEL Tokens are not a security in all jurisdictions. Each holder of STEEL Tokens shall bear its own legal or financial consequences of STEEL Tokens being considered a security in their respective jurisdiction. Every Purchaser is bound to check if acquisition and disposal of STEEL Tokens is legal in his jurisdiction, and by accepting this Agreement, each Purchaser undertakes not to use STEEL Tokens should their use not be legal in the relevant jurisdiction. If Purchaser establishes that the use of STEEL Tokens under this Agreement is not legal in his jurisdiction, You should not use the STEEL Tokens, not acquire them and should immediately stop using or possessing them if such case arises. Acquiring cryptographic Tokens for personal possession and exchanging them for other cryptographic Tokens will most likely continue to be scrutinized by various regulatory bodies around the world, which has so far given mixed reactions and regulatory impact. The legal ability of SISHUB to provide STEEL Tokens and the Platform in some jurisdictions may be eliminated by future regulation or legal actions. In the event, it turns out with a high degree certainty that STEEL Tokens are not legal in certain jurisdiction, SISHUB will either:

- a) cease operations in that jurisdiction, or
- b) adjust STEEL Tokens and the Platform in a way to comply with the regulation should that be possible and viable.

RISKS ASSOCIATED WITH ETHEREUM

22. STEEL Tokens are based on Ethereum blockchain. As such, any malfunction, unintended function or unexpected functioning of the Ethereum protocol may cause the STEEL Tokens to malfunction or function in an unexpected or unintended manner. Ether, the native unit of account of the Ethereum may itself lose value in ways similar to STEEL Tokens, and also other ways. More information about the Ethereum is available at <http://www.ethereum.org>.

RISK OF UNFAVORABLE REGULATORY ACTION IN ONE OR MORE JURISDICTIONS

23. Blockchain technologies have been the subject of scrutiny by various regulatory bodies around the world. The functioning of the Ethereum network and associated blockchain networks and STEEL Tokens could be impacted by one or more regulatory inquiries or actions, including but not limited to restrictions on the use or possession of digital Tokens like STEEL Tokens, which could impede or limit their existence, permissibility of their use and possession, and their value.

RISK OF THEFT AND HACKING

24. Hackers or other groups or organizations may attempt to interfere with Your Third-party Wallet, the Website or the availability of STEEL Tokens and Digital Assets in any number of ways, including without limitation denial of service attacks, Sybil attacks, spoofing, smurfing, malware attacks, or consensus-based attacks. You hereby agree that SISHUB shall have no liability for any such loss the Purchaser incur.

RISK OF SECURITY WEAKNESSES IN THE WEBSITE AND/OR STEEL TOKENS SOURCE CODE OR ANY ASSOCIATED SOFTWARE AND/OR INFRASTRUCTURE

25. There is a risk that the Website and STEEL Tokens may unintentionally include weaknesses or bugs in the source code interfering with the use of or causing the loss of STEEL Tokens.

RISK OF WEAKNESSES OR EXPLOITABLE BREAKTHROUGHS IN THE FIELD OF CRYPTOGRAPHY

26. Advances in cryptography, or technical advances such as the development of quantum computers, could present risks to cryptocurrencies, Ethereum, STEEL Tokens, the Platform, which could result in the theft or loss of STEEL Tokens.

RISK OF MINING ATTACKS

27. As with other decentralized cryptocurrencies, Ethereum blockchain, which is used for the STEEL Tokens, is susceptible to mining attacks, including but not limited to double-spend attacks, majority mining power attacks, “selfish-mining” attacks, and race condition attacks. Any successful attacks present a risk to the STEEL Tokens, expected proper execution and sequencing of STEEL Tokens, and expected proper execution and sequencing of Ethereum contract computations in general. Despite the efforts of SISHUB and Ethereum Foundation, the risk of known or novel mining attacks exists. Mining Attacks, as described above, may also target other blockchain networks, with which the STEEL Tokens interact with and consequently the STEEL Tokens may be impacted in that way to the extent, described above.

RISK OF LOW OR NO LIQUIDITY

28. Even though there are currently online services available, which enable possibility of exchange of cryptographic tokens between themselves, and also, some of them enable exchange of cryptographic tokens for fiat money, there are no warranties and/or guarantees given that STEEL Tokens will be listed or made available for exchange for other cryptographic tokens and/or fiat money, and no guarantees are given whatsoever with the capacity (volume) of such potential exchange. It shall be explicitly cautioned, that such exchange, if any, might be subject to poorly understood regulatory oversight, and SISHUB does not give any warranties in regard to any exchange services providers. Purchasers might be exposed to fraud and failure. In any case, SISHUB will not enable exchange of STEEL Tokens for other cryptographic tokens or for fiat currency. Purchaser may not at any given time be able to acquire or dispose of its STEEL Tokens due to lack of liquidity.

31. It is possible that the Ethereum network or any other network, to which the STEEL Tokens are interacting with, malfunctions in an unfavorable way, including but not limited to one that result in the loss of STEEL Tokens.

INTERNET TRANSMISSION RISKS

32. Purchaser acknowledge that there are risks associated with using the STEEL Tokens including, but not limited to, the failure of hardware, software, and Internet connections. Purchaser acknowledge that SISHUB shall not be responsible for any communication failures, disruptions, errors, distortions or delays You may experience when using the Website and STEEL Tokens, howsoever caused.

UNANTICIPATED RISKS

33. Cryptocurrencies and blockchains are new and untested technology. In addition to the risks set forth here, there are risks that SISHUB cannot foresee and it is unreasonable to believe that such risks could have been foreseeable. Risks may further materialize as unanticipated.

INSUFFICIENT INTEREST IN SISHUB, THE PLATFORM AND STEEL TOKENS

34. It is possible that SISHUB, STEEL Tokens or Platform will not be used by a large number of individuals, businesses and other organizations and that there will be limited public interest

in the creation and development of its functionalities. Such a lack of interest could impact the development of the Platform and usage of STEEL Tokens on it.

STEEL TOKENS AND THE PLATFORM, AS DEVELOPED, MAY NOT MEET THE PURCHASER'S EXPECTATIONS

35. The Platform is currently under development and may undergo significant changes before release. The Purchaser's expectations regarding the form and functionality of the Platform and STEEL Tokens may not be met upon release of new Website, deployment of the Platform, additional products and services for any number of reasons, including a change in the design and implementation plans and execution of the implementation of STEEL Tokens.

PROHIBITED ACTIVITIES

36. You are prohibited from violating any law, statute, ordinance or regulation in our registered jurisdiction as well as your country or residency by using STEEL Tokens.

37. You may not use your STEEL Tokens to engage in the following categories of prohibited activity and you confirm that you will not use STEEL Tokens to do any of the following:
Engage in a transaction involving the proceeds of any unlawful activity;

- 1) Defraud or attempt to defraud SISHUB or its affiliates;
- 2) Provide false, inaccurate or misleading information;
- 3) Infringe upon Company's or any third party's copyright, patent, trademark, or intellectual property rights;
- 4) Take any action that imposes an unreasonable or disproportionately large load on infrastructure of SISHUB, or detrimentally interfere with, intercept, or expropriate any system, data, or information;
- 5) Transmit or upload any material to the Platform that contains viruses or malware or any other harmful or deleterious programs;

52. All intellectual property rights comprised in the information, text, graphics, logos, images, audio clips, data compilations, scripts, software, technology, sound or any other materials or works found in the Website and Platform shall vest in and remain property of SISHUB and its affiliates. You are permitted to download and print such materials from the Website for personal and noncommercial use provided that You do not breach this Agreement.

53. SISHUB and its affiliates retain all intellectual property rights, mostly, but not limited, to copyright, over the source code forming STEEL Tokens, smart contract of the STEEL Token Sale, Website and Platform.

54. There are no implied licenses under the this Agreement and any rights not expressly granted to the Purchaser hereunder are reserved by the Company.
55. If for the purpose of any intellectual property right registration of the SISHUB, any documentary submission or any other action is required from the Purchaser, he/she/it must provide the Company with the respective assistance.

REPRESENTATIONS AND WARRANTIES

56. 57. By purchasing the STEEL Tokens the Purchaser represent and warrant that he has read and understand this Agreement and all Accompanying Documents in full and he fully agree with the information about the functionality of STEEL Token, usage, storage, transmission mechanisms and other material characteristics of the STEEL Tokens, blockchain technology, blockchain-based software systems and their risks, and appreciates the risks and implications of purchasing the STEEL Tokens.
58. You understand that the STEEL Tokens confer only the right to exchange STEEL Token for services on the Platform. You are not purchasing STEEL Tokens for any other uses or purposes, including, but not limited to, any investment, speculative or other financial purposes.
59. The Purchaser fully understands, realizes and agrees that the STEEL Tokens are created on a blockchain and are designed to be used in the manner described in Accompanying Documents Purchaser agree to accept consequences of possible regulation of SISHUB

Tokens in jurisdiction of the Company incorporation and agree to provide all documents requested from SISHUB in case of such regulation in order to comply with all requirements demanded from governmental bodies of jurisdiction of Company incorporation.

60. The Website may include general news and information, commentary, interactive tools, quotes, research reports and data concerning the financial markets, cryptocurrency market and other subjects. Some of this content is supplied by companies that are not affiliated with the Company (hereinafter referred to as "Third Party Content"). 61. Purchaser shall not forge, or otherwise manipulate any personal or non-personal data requested by the SISHUB in the process of the Purchaser's registration (will not use the VPN or other means of distorting the data), or after its completion, will provide all necessary personal or non-personal data in the form and format requested by the SISHUB in the event when such necessity arises in connection within the requirements of anti-money laundering and "Know Your Customer" (KYC) frameworks of the SISHUB or in accordance with the Applicable law.
62. Purchaser's acquisition of the STEEL Tokens complies with applicable laws and regulations in the Purchaser's jurisdiction;
63. 69. 73. 76. If the negotiations do not resolve the dispute, controversy or claim to the reasonable satisfaction of all Parties during such period, then the Parties irrevocably and

The Purchaser may terminate this Agreement without notice by discontinuing use of the Website. All rights granted to the Purchaser under this Agreement will immediately be revoked upon our termination of this Agreement or SISHUB suspension of the Your access to the Website. In the event of any circumstances beyond the control of the Parties, breach of this Agreement, or any other event that would make provision of services commercially unreasonable for SISHUB, the Company may, in its own discretion and without liability to the Purchaser, with or without prior notice, suspend the Purchaser's access to all or a part of SISHUB's Platform. 78. Only English versions of any Company's communications are considered official. The English version of this Agreement shall prevail in case of differences in translation.

79. Any notice or other communication under this Agreement shall be in writing and shall be considered given and received when sent by email. The Purchaser's official email for

communication shall be deemed the email specified by the Purchaser during the Application for Token Sale. The language of the communication shall be English.

80. Materials, such as SISHUB White Paper, Development Road Map and others, published in the Website or elsewhere, are not binding and do not – unless explicitly referred to herein – form part of this Agreement, and are of descriptive nature only.

81. Except as otherwise provided in this Agreement, this Agreement and the rights and obligations of the parties hereunder will be binding upon and inure to the benefit of their respective successors, assigns, heirs, executors, administrators and legal representatives. Company may assign any of its rights and obligations under this Agreement. No other party to this Agreement may assign, whether voluntarily or by operation of law, any of its rights and obligations under this Agreement, except with the prior written consent of the Company.

82. The Purchaser will implement reasonable and appropriate measures designed to secure access to:

- 1) Any device associated with the email address associated with the Platform;
- 2) Private keys required to access any relevant Ethereum address, and;
- 3) In case the Purchaser suspect a security breach in any of the above mentioned, he will inform SISHUB immediately so SISHUB can take all required and possible measures to secure the Website, the Platform, STEEL Tokens and systems as whole.
